	Provide latest information regarding the terms and conditions to foreign citizens who are interested to join the Malaysia My Second Home Programme	
	Prepare application together with the required documents for submission to the Immigration/Ministry of Tourism. This includes ensuring that the application form is properly filled up and all the required documents are attached and certified	
	Provide a Personal Bond to the Government of Malaysia to guarantee the good conduct of the participants throughout their stay in Malaysia under this programme. If the licensed companies clients are caught violating the terms and conditions of their stay in Malaysia, they are required to arrange for the immediate deportation of their clients back to their home country, including purchase of air tickets, food and lodging, etc.	
	Inform clients about the status of their application until they receive the Conditional Approval letter from Immigration Department. Advice client to come to Malaysia within 6 months from the date of approval of the Conditional Approval letter to fulfill all the required terms and conditions.

	Arrange for applicants to pay the required visa fees and have their passport stamped with Malaysia My Second Home sticker	
	<b>Alert</b> participants on the types of incentives they can now apply under this programme (Duty free Car, House loans and Maid). For example, they need to apply for prior approval from Treasury if they want to bring in their own car within 6 months from the date their passport is stamped with MM2H and not more than 1 year if they want to buy a locally assembled car
